

**THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL**  
**ARMED FORCES WEEKEND 2026**  
**VARIOUS STREETS, CLEETHORPES**  
**(TEMPORARY PROHIBITION OF TRAFFIC) (ATTRO) ORDER 2026**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), is satisfied that traffic should be prohibited for a purpose relating to danger or damage connected with terrorism on or near those roads and in exercise of its powers under Section 14(1)(b) by virtue of section 22C(4) and 22D of the Road Traffic Regulation Act 1984 (RTRA), as amended and of all other enabling powers the Council hereby makes the following Order;

1. Whilst the Order is in force, no person shall enter or proceed in, or cause any vehicle to enter or proceed along the full extent or any part thereof, the sections of highway specified in column 2 of the Schedule to this Order during the dates and times specified in column 1 of that Schedule; and
2. Article 1 of this Order shall be commenced, suspended or revived at the discretion of a police constable to such extent and for such period as they may specify. The police constable may delegate this authority under section 22D(5)(d) RTRA to an authorised agent or designated person for such period as they think necessary for a purpose relating to danger or damage connected with terrorism.
3. Pursuant to section 22D(5)(c), RTRA (which makes provision conferring a power on a police constable in relation to the placing of structures or signs, and the occasional deployment of search and screening capability), measures will be placed in the lengths of roads specified in column 2 of the Schedule to allow for the closure of these roads to vehicular traffic, passengers of such traffic and pedestrians except those vehicles or pedestrians allowed at the discretion of police constable or authorised agent or designated person.
4. Nothing in Article 1 to this Order shall apply to: -
  - (a) any vehicle being used for fire brigade, police or ambulance purposes;
  - (b) anything done with the permission or at the direction of a police constable in uniform, an authorised agent or designated person, or a civil enforcement officer;

There is currently no specific terrorism related intelligence in relation to this event and the threat to police officers and the threat to the UK from international terrorism are both currently at severe - an attack is highly likely. However, the measures are considered precautionary, proportionate and necessary for the safety and security plan for this particular event, and it is regarded by the Chief Constable of Humberside Police that these restrictions are an important part of his plan to avoid, or reduce the likelihood of, danger connected with terrorism.

The Interpretation Act 1978 shall apply in the interpretation of the order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Friday, 26 June 2026** until **Sunday, 28 June 2026** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport, or until such time as it is deemed by the Chief Constable of Humberside Police that the restrictions are no longer needed (whichever is the earlier).

In this Order, 'authorised agent or designated person' means any event stewards or security guards employed by a company contracted to provide security for the Armed Forces Event.

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(b) by virtue of section 22C(4) and section 22D, Armed Forces Weekend 2026, Various Streets, Cleethorpes (Temporary Prohibition Of Traffic) (ATTRO) Order 2026"
