

The Borough of North East Lincolnshire (Prohibition and Restriction of Waiting, Clearways and On Street Parking) (Consolidation) (Amendment No. 2) Order 2011.

The Borough of North East Lincolnshire in exercise of the powers under Sections 1(1) and (2), 2(1) to (3), 3(2), 4(1) to (3), 32, 33, 35, 37, 38(1), 45, 46, 46A, 49, 51, 53, 63A, 65, 68, 69, 71, 101, 102 and 116, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and the Traffic Management Act 2004 hereby make the following Order:

1. The Borough of North East Lincolnshire (Prohibition and Restriction of Waiting, Clearways and On Street Parking) (Consolidation) Order 2010 (as amended) shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order.

2. The effect of the Order will be to: -

a) Introduce a prohibition of waiting in the following locations:

lengths of roads within Cleethorpes

Alexandra Road, Kingsway, Park Street,

lengths of roads within Grimsby

Bratton Court, Central Parade, Greyfriars, Hume Street, Little Coates Road, Moody Lane, Oak Avenue, Sanctuary Way, Sutcliffe Avenue, Yarrow Road

lengths of roads within Immingham

Ancholme Avenue, Calder Close

lengths of roads within the parish of Laceby

Altoft Close, Cemetery Road

lengths of roads within the parish of Stallingborough

Trondheim Way

lengths of roads within the parish of Waltham

High Street

(b) Introduce waiting restrictions in the following locations:

lengths of roads within the parish of Great Coates

Station Road

(c) Revoke waiting restrictions in the following locations:

lengths of roads within Grimsby

Cleethorpe Road, Orwell Street

lengths of roads within Cleethorpes

Barkhouse Lane

(d) Introduce limited waiting facilities in the following locations:

lengths of roads within Grimsby

Un-named roads to the east and west of Town Hall,

- (e) Introduce loading only facility in the following locations;
lengths of roads within Cleethorpes:
Alexandra Road
- (f) Introduce prohibition of loading in the following locations:
lengths of roads within Cleethorpes
Sea View Street
- (g) Introduce 24 hour rural clearway in the following locations:
lengths of roads within the parish of Healing
A1136

These restrictions will replace any existing restrictions currently in force.

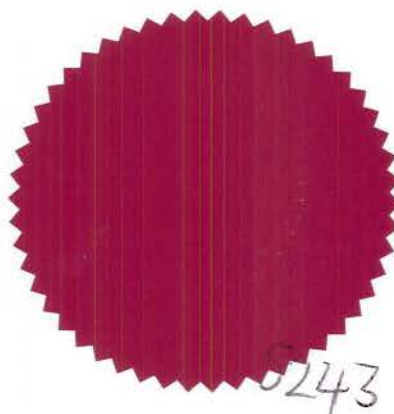
