## THE NORTH EAST LINCOLNSHIRE COUNCIL (WALTHAM PUBLIC FOOTPATH NO. 78) DEFINITIVE MAP MODIFICATION ORDER 2024

This order is made by North East Lincolnshire Council (hereinafter called "the Authority") under Section 53 (2)(b) of the Wildlife and Countryside Act, 1981 (hereinafter called "the Act") because it appears to that Authority that the North East Lincolnshire Definitive Map and Statement require modification in consequence of an event specified in Section 53 (3)(c)(i), namely the discovery of evidence which (when considered with all other relevant evidence available to the) shows that a right of way which is not shown in the Map and Statement subsists or is reasonable alleged to subsist over land in the area to which the Map relates.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates.

The Authority hereby orders that:

From Point A the path runs in a north easterly direction for approximately 79 metres to small bridge where it runs approximately 2 metres to Waltham, Public Footpath 66 Point B on the attached plan (Ordnance Survey Grid Reference TA526293, 403901). The total length being 81 metres.

The width varies from 5 metres to 1 metre as shown in the Definitive Statement.
