

## Licensing Act 2003

### Representation on a Licensing Application

Representations may be made at any time during a period of 28 consecutive days starting on the day after the application was given to the Licensing Authority.

In the case of a closure order issued by the Police, representations may be made during the seven days that follow relevant notice being given to the Local Authority by the Magistrates Court, starting on the day after the day the notice was received.

Representations must be relevant to the application. To be relevant they must relate to at least one of the four **Licensing Objectives** listed below:

- **The Prevention of Crime and Disorder**
- **Public Safety**
- **Prevention of Public Nuisance**
- **The Protection of Children from Harm**

**Note:** Please be aware that that this form cannot be treated as confidential. Your representation will be passed to the Applicant or to the representative of the Applicant to allow them the opportunity of addressing your concerns. This form will also be published on the council's website and read out in public at the sub-committee hearing.

The Prevention of Crime and Disorder	<p>Grant Thorold Park and the surrounding area has suffered high levels of ASB, in particularly over the summer period. Wheelie bins were being burnt out every day, glass bottles were being smashed which caused dog walkers problems, trees and plans were damaged.</p> <p>Residents told Ward Councillors that there was underage drinking, every night on the park, and that this was linked to the criminal activity.</p>

Prevention of Public Nuisance	<p>I realise that there is no cumulative impact assessment for this part of the East Marsh, but there are many premises selling alcohol within a few hundred yards of the park. Residents are fed up with impact that these premises are having on our area; one more application will have a detrimental effect.</p>
<b>The Protection of Children from Harm</b>	<p>As I said earlier, Ward Councillors receive regular reports of children drinking in the park and the surrounding area. NELC is committed to becoming a Marmot Council, the Council want to:</p> <p>Give every child the best start in life</p> <p>Enable all children, young people and adults to maximise their capabilities and have control over their lives</p> <p>Ensure a healthy standard of living for all</p> <p>Create and develop healthy and sustainable places and communities</p> <p>Strengthen the role and impact of ill health prevention</p> <p><b>In my opinion this application will only hinder the progress to becoming a Marmot Council.</b></p>
