We already have a convenience store not 200 meters from this location and 2 supermarkets within walking distance. There is no need for another off licence, in the area or another convenience store.

We have plenty of shops in the area already, It would be much better to have something like a take away (which the building was used for previously) or some other form of service down the street.

We do not need another off licence, especially one which encourages more trouble down the street due to it being the only one open in the area midnight serving refreshments. This will cause major disruption down the street at night.

So I am raising my concerns and making it clear I am opposed to this licence, and to yet another shop being opened down a street that does not require it.

Representation:

Humberside Police would like to object to the New Application for Todays.

Humberside Police is objecting due to an agreement not being reached for all conditions, mostly surrounding the high strength alcohol that is being sold in the store.

The proposed conditions that are not agreed are:

- Spirits with an ABV above 20% will be kept behind the counter or other Police approved secure display. Spirits will only be displayed, offered or sold in bottles no less than 35cl
- The premise will not display, offer, or sell any beers, lagers, ciders or pre-mixed spirit drinks with an ABV in excess of 6.5 %.
- All beer, lager and cider displayed for sale in cans will only be sold in minimum packs of 4 cans, there will be no sales of individual cans of beer, lager or cider.

The premises are located in close proximity to the town centre. It is known that street drinkers often purchase alcohol from shops on the outskirts and consume it in the town centre, contributing to anti-social behaviour and criminal activity. There are also issues in the area where persons have purchased alcohol, namely the spirit drinks, for consumption by underage persons.

Humberside Police are actively working to reduce such behaviour and promote a safe and welcoming environment. Permitting the sale of high-strength alcohol at this location risks undermining these efforts. Other shops identified as contributing to these issues have been asked to amend their licence conditions accordingly.

The shop is in a residential area. There are concerns that those that are classed as street drinkers may attend the shop, cause issues or congregate outside the shop whilst drinking, which can negatively impact residents. By removing the alcohol that they desire (high strength and low cost) will help mitigate this risk and support responsible alcohol consumption.

Humberside Police are not satisfied that any of the Licensing Objectives will be sufficiently upheld, despite the other agreed conditions, without these 3 key conditions, as required by the Licensing Act 2003.

Discussions regarding the conditions will continue in an effort to reach agreement.

Humberside Police reserve the right to serve further evidence in due course.
