- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the Operating Schedule

- There will be no adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children
- CCTV system is installed at the site in accordance with Police requirements
- First Aid Kit available on premises at all times
- Soft drinks and non-alcoholic drinks will be available
- A recognised proof of age policy will be enforced

Annex 3 - Conditions attached after a hearing by the licensing authority

- No off sales of alcohol shall be permitted from the premises at any time
- All diners shall vacate the premises at 01:00 hours and 02:00 hours as per the application
- Music to be by way of background music only and must not be "regulated entertainment"
- The sale and supply of intoxicating liquor to be by waiter service to diners at tables only
- There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public, notices asking customers to respect the needs of local residents and requiring customers to leave the premises and the area quietly
- An agreement with a special taxi company will be put in place, in which drivers will be asked not to beep their horns
- That children will be required to be supervised by the accompanying adult at all times
